

## Privacy Notice on the Processing of Personal Data

Your personal data are processing by Borusan Enerji Çözümleri Sanayi ve Ticaret Anonim Şirketi (“**Borusan**” or “**Company**”) as the data controller in accordance with [Turkish Data Protection Law numbered 6698](#) (“**Law**”).

This Privacy Notice aims to inform you on how your personal data are being processed.

[power.fgwilson.com](#) is a digital service channel which is provided Borusan and our Costumers’ services. Through this site, our customers may access information regarding their relations with Borusan, including equipment, offers, reservation information through digital media, and our customers may send us support, offers and reservation requests regarding our products/services via the site. Within the scope of these processes, your personal data are processed in accordance with our privacy notice.

### Purposes and Legal Grounds for Processing Your Personal Data

Your personal data are processed based on the legal grounds specified in Article 5 of the Law. Below, we have listed the purposes for which we process personal data and the legal grounds we rely on for such purposes:

<i>Processing is necessary to process the personal data of the parties of a contract, provided that it is directly related to the establishment or performance of a contract</i>	<ul style="list-style-type: none"><li>· To fulfill your requests regarding our products and services through digital media; carrying out operational activities for the performance of the contract between us (to exemplify, receiving your requests on equipment and reservation, receiving and fulfilling your support requests such as installation support, maintenance guarantee, creating your customer record for the execution of your transactions).</li></ul>
<i>Fulfilling our legal obligations</i>	<ul style="list-style-type: none"><li>· To fulfill our legal obligations in cases where authorized institutions or organizations make a request from our Company or when we are expected to notify these institutions (for example, sharing your personal data when a public institution requests a transaction that is suspected of illegal transaction).</li></ul>
<i>Processing is necessary for the establishment, exercise or protection of any right</i>	<ul style="list-style-type: none"><li>· To verify your information and creating your account</li><li>· To detect any suspicious/unlawful transactions within the scope of access and use of our site; in this context, protecting the rights of our customers and our Company,</li><li>· To protect and exercise our rights in case of a possible dispute and to carry out legal processes.</li></ul>

### **Processed Personal Data**

Within the scope of the purposes and legal grounds in this privacy notice, your identity, communication, customer transaction, information about the company you are authorized and your job, financial information, suggestions, requests and complaints, legal transaction information and transaction security information are processed.

### **The Parties We Share Your Personal Data with and the Purposes of Sharing**

Your personal data shall be shared with authorized institutions and organizations within the scope of our legal obligations and legal processes. Your personal data shall also be transferred to our group companies, service providers and business partners, based on the legal grounds stated above, in order to achieve the above-mentioned purposes. In sharing your personal data with third parties, compliance with the rules regarding the personal data transfer specified in Articles 8 and 9 of the Law is ensured.

### **Methods of Collecting Your Personal Data and the Legal Grounds**

Your personal data are collected by automated and partially automatic methods through digital media, communication channels including e-mail and telephone. In cases where you provide your personal data to us in a physical environment, your data is also collected by non-automatic methods, provided that it is part of the data recording system. While processing your data, we act based on the legal grounds stated in Article 5 of the Law, as the establishment or performance of a contract, the fulfillment our legal obligations, the establishment, exercise or protection of a right, the necessity of data processing for our legitimate interests and the explicit consent of the data subject.

### **Exercise of Data Subject Rights**

Article 11 of the Law regulates the rights of natural persons whose personal data are processed. You have the following rights under this provision:

- To learn whether your personal data are processed or not,
- To request information, if your personal data has been processed,
- To learn the purpose of processing your personal data and whether they are used in compliance with the purpose,
- To know the third parties whom your personal data are transferred in the country or abroad,

- To request the correction of your personal data in case of incomplete or incorrect processing and to request the notification of the transaction made within this scope to the third parties to whom your personal data has been transferred,
- To request the deletion or destruction of your personal data in the event that the reasons requiring processing are eliminated, although it has been processed in accordance with the provisions of the Law and other relevant Laws, and to request the notification of the transaction made within this scope to the third parties to whom your personal data has been transferred,
- To object to the occurrence of a result against you by analyzing the data processed solely through automated systems,
- To claim compensation for the damage arising from the unlawful processing of your personal data.
